Whereas, the purpose of Grassroot Cutting Horse Association Inc. (GRC) is to promote and enjoy the use of cow horses, which includes strenuous physical activity by horse and rider, the unpredictability of cattle and arena surfaces, the close proximity of other horses and various unknown and unexpected conditions, circumstances and happenings common to activities of this kind, each participant agrees to <u>ASSUME ANY AND ALL RISKS</u> for personal or property damage for any acts or accidents to himself/herself, ranch, business or family members while attending any function sponsored by GRC

Each participant further agrees to <u>HOLD HARMLESS</u> any person or property, including, but not limited to GRC, it's officers, directors, members, employees, contractors, sponsors, volunteers, spectators, the owners and/or operators of any property, facilities, or equipment either owned, loaned, borrowed, leased, and/or rented in any and all activities sponsored by GRC.

All Members additionally agree that any dispute in regard to this agreement, its interpretation or applicability, any and all issues regarding damages, causation, or any other issue in which GRC or its officers, directors, members, employees, contractors, sponsors, volunteers, owners and/or operators of any property, facilities or equipment shall be submitted to binding arbitration pursuant to Title Seven, Chapter 9, of the Uniform Arbitration Act of the Idaho Code.
